

How to Order a Tax TranscriptX (Form 8821 – Halcyon) Within Xactus360

1. Start by logging into Xactus360 and from the home page, click Order Tax TranscriptX.

2. Under 'Transcript Product' select Order TTX (Form 8821 / Halcyon). Then select either Personal or Business under 'Transcript Type'. Choose whether the borrower has an IRS account or not and complete all fields for the order including Name, SSN, Email Address, Address, and which Form Type and Available Years are needed.

3. The 8821/authorization form is mandatory and can be uploaded by clicking Choose File and ensure the correct email address is listed for the Notification and enter a secondary email if needed. When all is complete, click Submit.



4. The 8821 Form can be downloaded by clicking the link on the left-hand side under Resources.



5. It is recommended that the borrower have an account with the IRS prior to submitting the order for the fastest turnaround time. If the borrower does not have an account, one can be setup prior to your order by clicking the link on the left-hand side under Resources.



6. If at any time additional transcripts are needed or you need to update the order information, click Add Transcripts or Update Form/Borrower under Actions.



7. In some instances, the status will read 'Action Needed'.
