

How to Order an Asset VerificationX via AccountChek Within Xactus360

1. Start by logging into Xactus360 and from the home page, click Order Asset VerificationX.

The authentication to the borrower can be emailed or texted. Once all fields are complete, click Order. This will initiate an email sent to the applicant to complete the authentication process.
